Pickup and Dropoff:

Parents are responsible for bringing their child/ren into the Education Building of FBC Lexington and sign them in and out each day, using the side entrance. On the enrollment form, list all persons authorized to pick up your child in both normal and unusual circumstances. All persons not known to the staff will be asked to show identification.

What to Bring:

Children must wear tennis shoes. We will be playing outside every day, weather permitting. Each child should bring an extra set of clothes and a bottle of sunscreen in a backpack in case needed. On swim days, children will need a towel, flip flops and bathing suit for pool time. Children should have sunscreen applied each day at home before coming to camp. Children will be given time to reapply sunscreen before going outdoors in the afternoon. Be sure to send sunscreen that the child can apply by themselves. Do not bring toys or electronics from home, unless requested to do so.

Payment:

Parents/Guardians are responsible for prompt payment of \$110 per week for each child in attendance for a total of 10 weeks. Payment is due no later than drop off time of the week in attendance. Payment may be made through electronic means. More information will be given about this method at a later date. The total cost for the summer is \$1100.

- 1. Applications cannot be confirmed unless accompanied by a \$25 registration fee per camper. The fee is non-refundable.
- 2. Camp size will be limited and reservations will be based on the date of the paid registration.
